Evidence

What are you demanding?

☐ Infringement of copyright, trademark right, trade name right or other right of the person making the report
Racist statement, hate speech or discriminatory statement
☐ Slander or defamation of or insult or threat towards the person making the report
☐ Violation of privacy or portrait rights of the person making the report (including stalking)
☐ Child pornography or other illegal pornographic publication
☐ Image or text of pornographic nature or otherwise with sexual overtones
☐ Computer crime (hacks, viruses, etc.)
☐ Publication of your personal data without your consent
